A Type I Certificate authorizes a technician to purchase and handle refrigerant in the maintenance, service, or repair of small appliances that are fully manufactured, charged, and hermetically sealed in a factory with five (5) pounds or less of refrigerant. Among others, these include home refrigerators and freezers, room air conditioners (to include packaged terminal air conditioners) and packaged terminal heat pumps.
