DISCIPLINARY ACTION

Penalties for violation of the licensing law and Board rules vary depending on the facts and circumstances of each case.

BAKER, Bobby, dba Bobby Baker Refrigeration, Rolesville, NC. Allegations of refrigeration contracting without a license. The Board filed a complaint for injunctive relief in Wake County Superior Court. The defendant did not answer the complaint and the Board obtained both a default judgment and permanent injunction on August 1, 2012 permanently prohibiting the defendant from engaging in refrigeration contracting.

FAVAZZA, Vinny, dba Penske Trucking Leasing, Charlotte, NC. Allegations of refrigeration contacting without a license. Board approved a Cease and Desist Order on September 7, 2012 demanding respondent immediately cease and desist from offering or rendering commercial refrigeration contracting without a valid refrigeration contractors' license issued under the provisions of NCGS 87-57.

HAWS, Mr. & Mrs. Brian, dba Mechanical HVAC Services, Wake Forest, NC. Allegations of refrigeration contracting without a license. Letter of Warning signed March 19, 2012 cautioning respondent against doing refrigeration contracting without a valid refrigeration contractors' license issued under the provisions of NCGS 87-57.

HOWSARE, Eric, Rock Hill, SC – Allegations of refrigeration contracting without a license. Board approved a Cease and Desist Order on May 18, 2012 demanding respondent immediately cease and desist from offering or rendering commercial refrigeration contracting without a valid refrigeration contractors' license issued under the provisions of NCGS 87-57.

LENT, Gary, dba D & G Services, Elizabethton, NC. Allegations of refrigeration contracting without a license. Board approved a Cease and Desist Order on May 8, 2012 demanding respondent immediately cease and desist from offering or rendering commercial refrigeration contracting without a valid refrigeration contractors' license issued under the provisions of NCGS 87-57.

SMITH, Brian, dba Albemarle Air Conditioners, Hertford, NC. Allegations of refrigeration contracting without a license. Letter of Warning signed December 10, 2012 cautioning respondent against doing refrigeration contracting without a valid refrigeration contractors' license issued under the provisions of NCGS87-57.

INTERPRETIVE STATEMENTS

As a reminder, the following interpretive statements have been adopted by the Board:

Interpretation of Insulated Panel Structure Under G.S. 87-58

Under G.S. 87-58, which defines refrigeration trade or business, an insulated panel structure becomes a refrigerated structure when the evaporator coil is installed and falls under the authority of the Board.

Interpretation of the meaning of 'connection' as used in G.S. 87-62

Interpretation of the meaning of 'connection' as used in G.S. 87-62. In context, the term 'in connection' means having a legal relationship which, by law, would impose direct legal liability for contractual obligations and regulatory compliance. Such persons would only include sole proprietors, partners, employees or corporate officers. Unless otherwise evidenced in writing, independent contractors would not be 'connected'. Subcontractors could be connected but only if there is a written agreement documenting the legal relationship.

Interpretative Statement Regarding Geothermal Refrigeration Installations

It is illegal for a well contractor to contract the geothermal piping installation even if the geothermal piping installation is subcontracted to a licensed refrigeration contractor. In addition it is illegal for a licensed refrigeration contractor to subcontract these installations from a well contractor.
