2008 Scholarships Awarded

The State Board of Refrigeration Examiners recently awarded scholarships to Jared Scott McLamb and John J. Wynn. Mr. McLamb attends Wake Technical Community College and is enrolled in the HVAC/R curriculum. Mr. Wynn is attending Martin County Community College and is enrolled in the Commercial Refrigeration curriculum.

Scholarships are available to persons enrolled in or interested in enrolling in an Associate in Applied Science Degree Program of study in HVAC/R technology as well as those persons interested in enrolling in or enrolled in an Associate in Applied Degree Program of study in Commercial Refrigeration.

Applicants must meet the following criteria to qualify for a scholarship: (I) Be a resident of N.C.; (2) Be enrolled (or must intend to enroll) in an Associate in Applied Science

Degree of Study in Commercial Refrigeration or HVAC/R Technology; (3) Maintain a grade point average at or above the level required for graduation; and (4) Continue for the duration of the scholarship at the college where he or she was enrolled at the time of the scholarship award.

Two or more scholarships are awarded annually depending on available funds. Scholarship checks will be made payable jointly to the individual recipients and to their community colleges. The annual award will not be greater than the total of the student's tuition, books and supplies for two semester of the academic year.

Disciplinary Action

Penalties for violation of the licensing law and Board rules vary depending on the facts and circumstances of each case.

Kiser, David, dba Kiser Refrigeration A/ C Sales & Service, Johnsonville, SC. Allegations of refrigeration contracting without a license. The Board and Defendant Kiser entered into a Consent Judgment whereby the court ordered that the defendant be permanently enjoined from engaging in the "refrigeration trade or business" until such time, if any, that the defendant shall obtain a license allowing him to engage in the refrigeration trade or business. Any violation of this permanent injunction shall be deemed contempt of court and shall be punishable by both civil and criminal contempt power of the Court. The Superior Court of Wake County will retain jurisdiction over this civil action for the

purposes of enforcing this judgment. The Board was awarded the cost of court.

Mattox, Randall, License T0060, dba Preventive Maintenance Service of America, Eden, NC. Allegations of misconduct in the business of refrigeration contracting in that the licensee performed work outside the scope of his transport refrigeration license. This constitutes of violation of NCGS 87-58(d). Consent order entered by the Board on March 11, 2008 prohibiting the licensee from performing commercial refrigeration services unless and until he is licensed as a commercial refrigeration contractor and imposing a civil penalty of \$250.00 stayed on the condition that he not violate the terms of the consent order.

Mullinax, Rick, License 3932, Shelby, NC. Allegations of misconduct in the business of refrigeration contracting in that the licensee failed to obtain a permit as required by building authorities to perform refrigeration work. Additionally licensee failed to supervise the installation of a job performed under his licensee. This constitutes a violation of NCGS 87-62(A) and 21 NCAC 60.0311 and .0314. Consent order entered by the Board on March 11, 2008 reprimanding the licensee.

You are reminded that only the replacement of lamps and fuses and the installation and servicing of domestic household refrigerators and freezers and domestic ice-making appliances connected by means of attachment plug-in devices are excluded from the requirements of the law governing refrigeration contracting.
